APPLICATION FOR EXEMPTION FROM SUPERVISORY ACCOMPANIMENT – INSTRUCTIONS

Before this application can be filed with the Board, the applicant must have completed the required qualifying education (including the 4 hour Supervisor-Trainee Course for West Virginia), required experience hours and passed the 3 hour WV Law Course.

1. Application must be legible. Please type or print clearly in ink.
2. Application Fee of \$150 is *non-fundable fee*. If the application is returned for any reason, the application fee will not be re-funded. Re-submission of the application will require an additional application fee of \$150.
3. Securely tape a photograph taken within the past year to the application where indicated.
4. Enclose the Original Experience Logs that reflect the minimum 500 experience hours required for the requested exemption.
5. Enclose a Supervisor Oath and Affidavit for each supervisor that has signed the experience logs.
6. Mail completed application and application fee in the form of a check or money order and made payable to the WV Real Estate Appraiser Board to: **WVAB, PO Box 40267, Charleston, WV 25364**. THE BOARD OFFICE CANNOT ACCEPT DELIVERY OF FEDERAL EXPRESS, UPS, OR OTHER DELIVERY SERVICES.

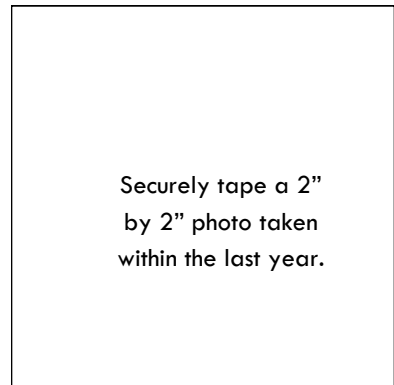
