

West Virginia Real Estate Appraiser Licensing and Certification Board Approved Qualifying Education Courses Classroom/Synchronous/Hybrid/Asynchronous (Online)

Revised November 1st, 2024

NOTE: Per the AQB, educational offerings that have been approved for classroom presentation for QE credit are approved for synchronous presentation for QE credit, providing the instructor and students interact simultaneously online/virtually.

Hybrid courses, AKA blended courses, are learning environments that allow for both in-person and online (synchronous, or asynchronous) interaction.

In asynchronous (online/distance) educational offerings, the instructor and student interaction is non-simultaneous; the student's progress at their own pace and follow a structured course content and quiz/exam schedule.

In addition to Qualifying Education, there is a college requirement for a Certified Residential Appraiser and Certified General Appraiser credential, per WV190CSR2.
